I refer to the email of 6 December 2017 you sent to Police seeking information pertaining to the classifications of firearms licence holders and firearms over the past 20 years. Your request was made pursuant to the Official Information Act 1982 and specifically requested:

- Please advise the numbers of firearms licence holder of different classifications over the past 20 years.
- 2. Please advise the (estimated) numbers of firearms of different classifications over the past 20 years, or if 20 years is not feasible, then as far back as is reasonably possible.
- Please advise the type of sources used to estimate/calculate the numbers of firearms.

My response is outlined below.

 Please advise the numbers of firearms licence holder of different classifications over the past 20 years.

Police are unable to provide you with the different classifications of firearms licence holders over the past 20 years as the data is drawn from a dynamic operational database. They are subject to change as new information is continually recorded. The below data were drawn on 20 December 2017.

Listed in the below table are all people who have a current, expired, awaiting action, or a renewal of their licence in progress. Some people have more than one licence (eg, a licensed dealer who may also have a personal firearms licence). Hence the number of licences may be greater.

2. Please advise the (estimated) numbers of firearms of different classifications over the past 20 years, or if 20 years is not feasible, then as far back as is reasonably possible.

There is no requirement for firearms to be registered in New Zealand nor is there any obligation to provide Police with the serial numbers of firearms. Registration of firearms was ceased with the implementation of the Arms Act 1983 that came into force in July 1984.

The Arms Act 1983 centres on the licensing of persons who can satisfy Police that they are fit and proper to be in possession of firearms.

The potential risks associated with some particular types of firearms are dealt with through the endorsement system. Endorsements on firearm licences are required for the possession of pistols, military style semi-automatic firearms (MSSAs) and restricted weapons which require Police to consider further criteria. Endorsed firearms and weapons must be registered.

The below table shows the number of firearms that were created in the Police database by date of creation regardless of the current status of the firearm or whether the entry of the firearm was through registration or stolen occurrence, permits or seizures. Note that restricted weapons could include any restricted weapons as defined under Schedule of the Arms (Restricted Weapons and Specially Dangerous Airguns) Order 1984.
