REPORT NOTES:

An incident that is reported to or detected by Police where Police believe an offence is likely to have been committed is counted as a Recorded Offence.

A Recorded Offence is considered to be a Resolved Offence by Police when an offender is identified and dealt with. (E.g. warned, cautioned, prosecuted, etc.)

Resolution Rate is the percentage of Recorded Offences that are resolved.

Statistics reported in this document are derived from the Justice sector Law Enforcement System (L.E.S.). These Official Crime Statistics present a snapshot of data in L.E.S. relating to offences within a given year, as at the date 14 days following the end of that year.

If an offence is resolved 15 days or more after the end of the year it will not appear in the Official Crime Statistics for that or any other year. Resolution Rate therefore undercounts the number of cases that Police have resolved. This phenomenon has a more marked impact for some types of offences than others, such as offences that require long investigations (E.g. many serial crimes, burglaries and murders).

From time to time, changes occur to Police offence codes. These changes occur for reasons such as changes in legislation or the desire to gain more specificity in statistics for certain types of offences. Caution should therefore be observed when interpreting step-increases and decreases in the number of recorded offences of a certain type.

Significant changes to use of Police offence codes in 2004 include:

The Local Government Act 2002 Ammendment Act 2004 increased Police powers of Arrest for Breaches of Liquor Bans. This may be reflected in the 2004 Liquor Ban Breach Offence counts (grouped in the Sale of Liquor Act 1989 Offence Class. Note also that prior to July 2003, Breach of Liquor Ban Offences were included in the ByLaw Breaches Class. (within the Administrative Category)

The Maritime Security Act 2004 came into force on the 6th of April 2004. New offences for this and related acts were added within the Immigration Class.

Justice (Special) Offences in 2004 resulted from the Sentencing Amendment Act 2004 and the Parole (Extended Supervision) Amendment Act 2004 both of which came into force on the 7th of July 2004.

When comparing 2004 Statistics with 2003 and previous years, the reader should also refer to "Report Notes" published with the 2003 Statistics, as changes during 2003 significantly affect year on year trends.





Recorded Offences per 10,000 population









(percentage of recorded offences that are resolved)









Population Data

Population data is used in this release to calculate crime rates. These data are estimated population figures as at 30 June each year obtained from Statistics New Zealand.

The estimated resident population is based on the census usually resident population count, with adjustments for residents missed or counted more than once by the census (net census undercount), and for residents temporarily overseas on census night.

These population estimates exclude an increasing number of international students who are studying in New Zealand for less than 12 months.
