REPORT NOTES:

Statistics reported in this document are derived from the Police National Intelligence Application (N.I.A) These Official Crime Statistics present a snapshot of data in N.I.A. relating to offences within a given year, as at the date 14 days following the end of that year.

An incident that is reported to or detected by Police where Police believe an offence is likely to have been committed is counted as a Recorded Offence.

A Recorded Offence is considered to be a Resolved Offence by Police when an offender is identified and dealt with. (E.g. warned, cautioned, prosecuted, etc.)

Resolution Rate is the percentage of Recorded Offences that are resolved.

If an offence is resolved 15 days or more after the end of the year it will not appear in the Official Crime Statistics for that or any other year. Resolution Rate therefore undercounts the number of cases that Police have resolved. This phenomenon has a more marked impact for some types of offences than others, such as offences that require long investigations (E.g. many serial crimes, burglaries and murders).

Note that the Population Estimates have been revised for 2002 to 2006 as a result of the 2006 Census. In previous reports population estimates were based on the 2001 Census. Crime rates reported in this report for those years may differ from those previously reported as a result.

Legislation changes during 2008 have generally had negligible impact on total recorded crime statistics. However, expanded graffiti legislation under sections 11A and 11B of the Summary Offences Act 1981, have resulted in new offence codes being created to capture some of the graffiti offences more explicitly, and to create a new offence for being in possession of graffiti implements without reasonable excuse. The net impact of this legislation change would be a very small increase in the number of offences recorded.

When comparing 2008 Statistics with previous years, the reader should also refer to "Report Notes" published in previous years' reports, as previous changes significantly affect year on year trends.







Recorded Offences per 10,000 population





Population Data

Population data is used in this release to calculate crime rates. These data are estimated population figures as at 30 June each year obtained from Statistics New Zealand.

The estimated resident population is based on the census usually resident population count, with adjustments for residents missed or counted more than once by the census (net census undercount), and for residents temporarily overseas on census night.

These population estimates exclude an increasing number of international students who are studying in New Zealand for less than 12 months.

Note that 2002-2008 estimates are based on the 2001 and 2006 Census data. Estimates have been revised since the previous publication of this report.
