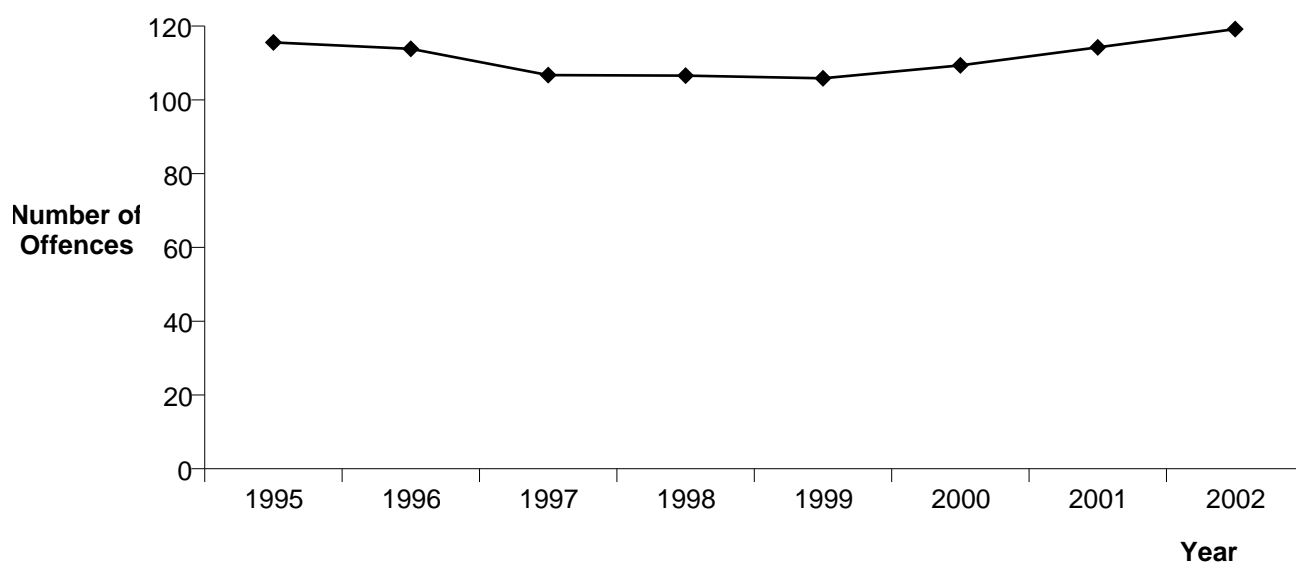

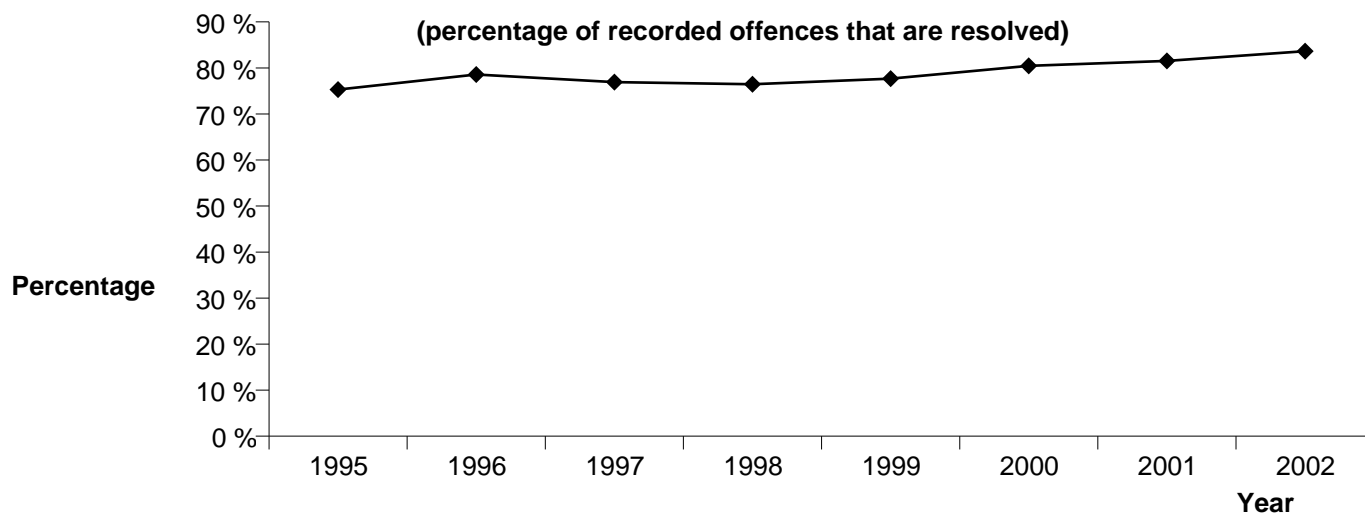

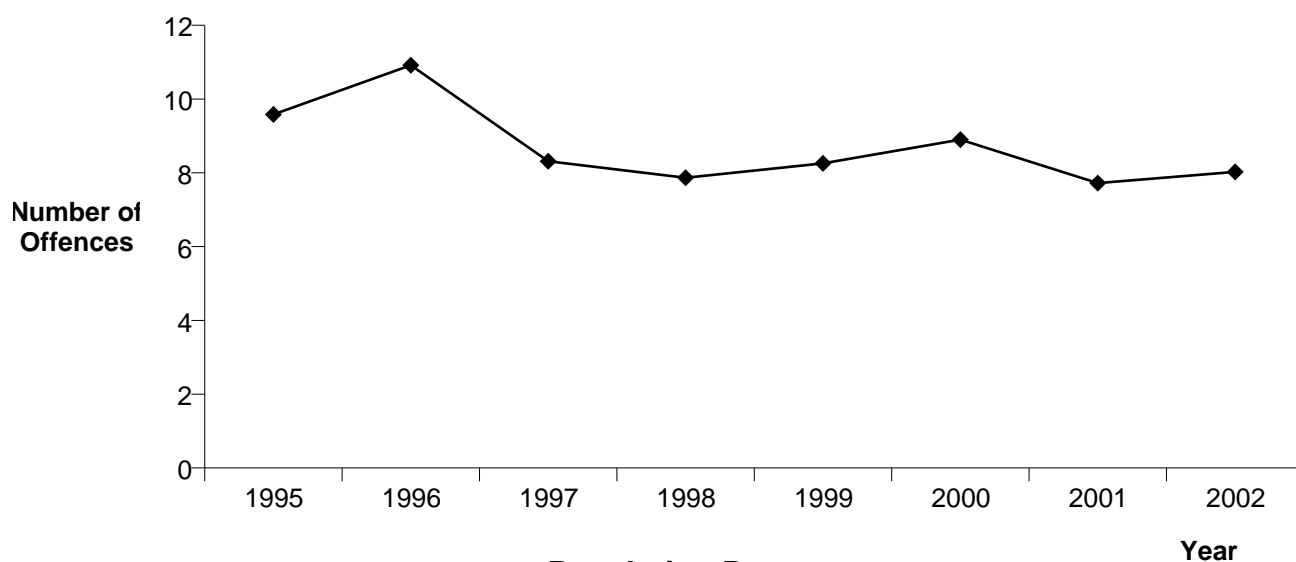

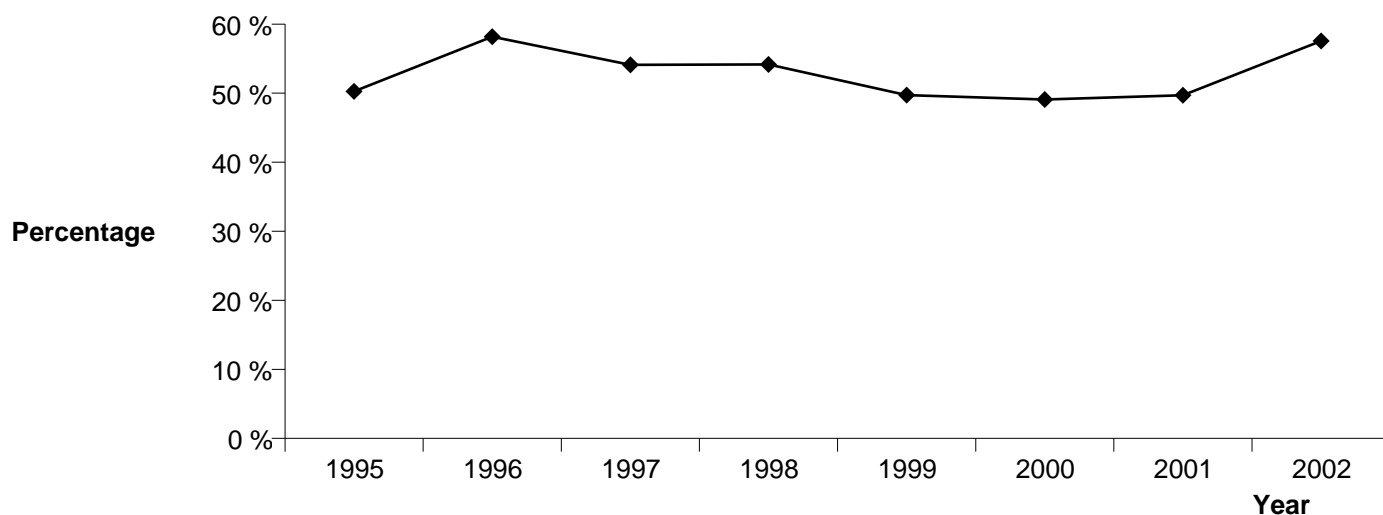

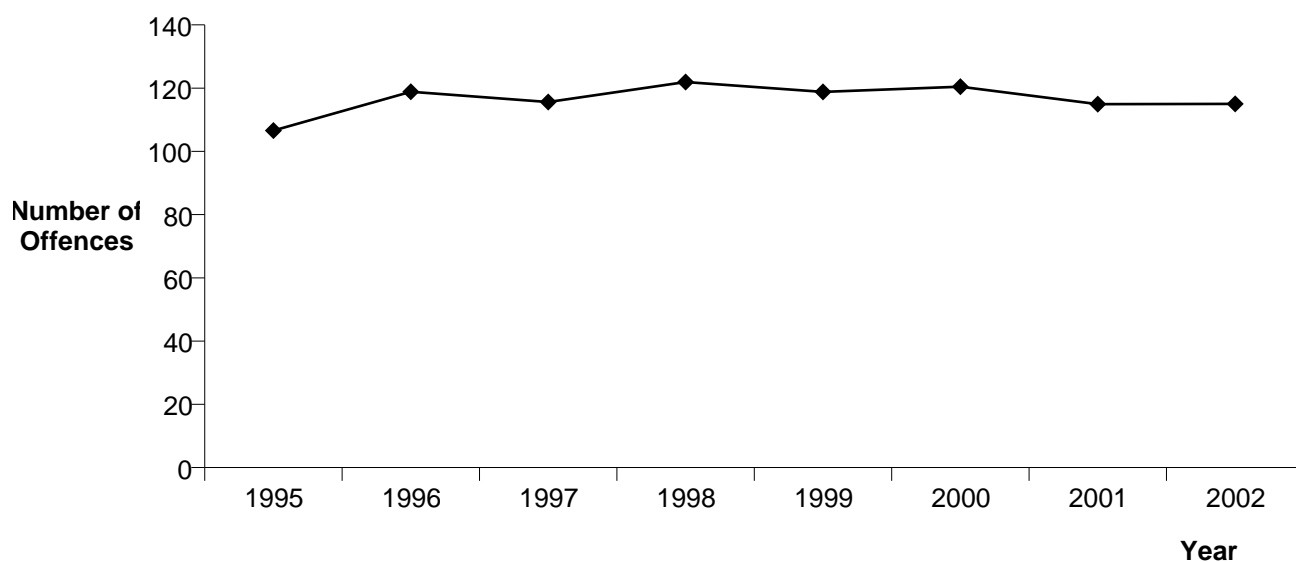

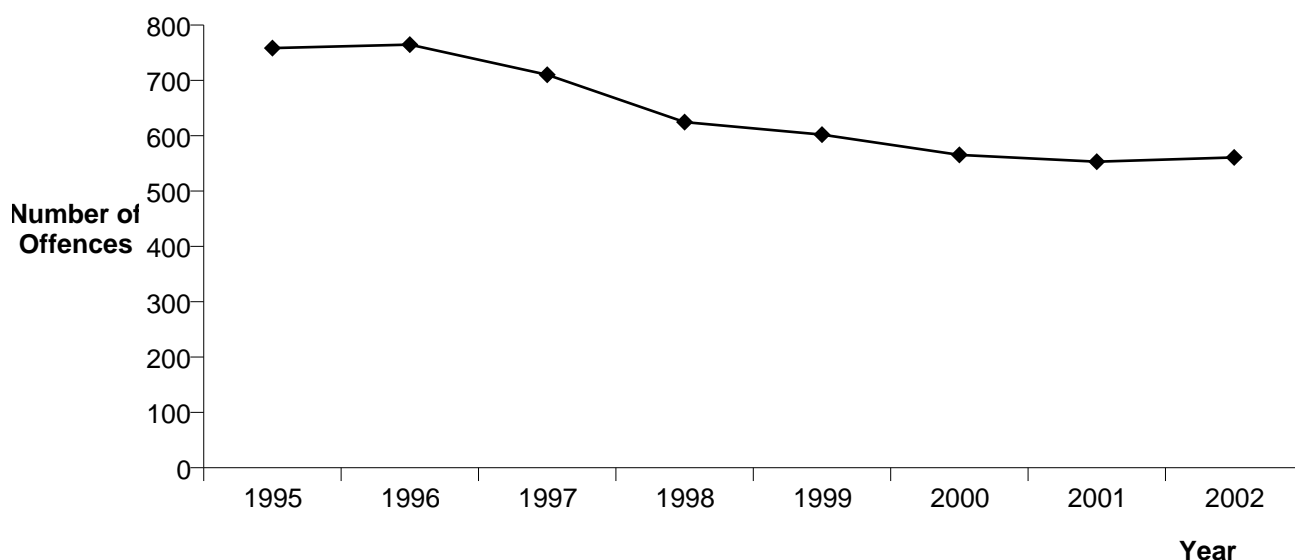

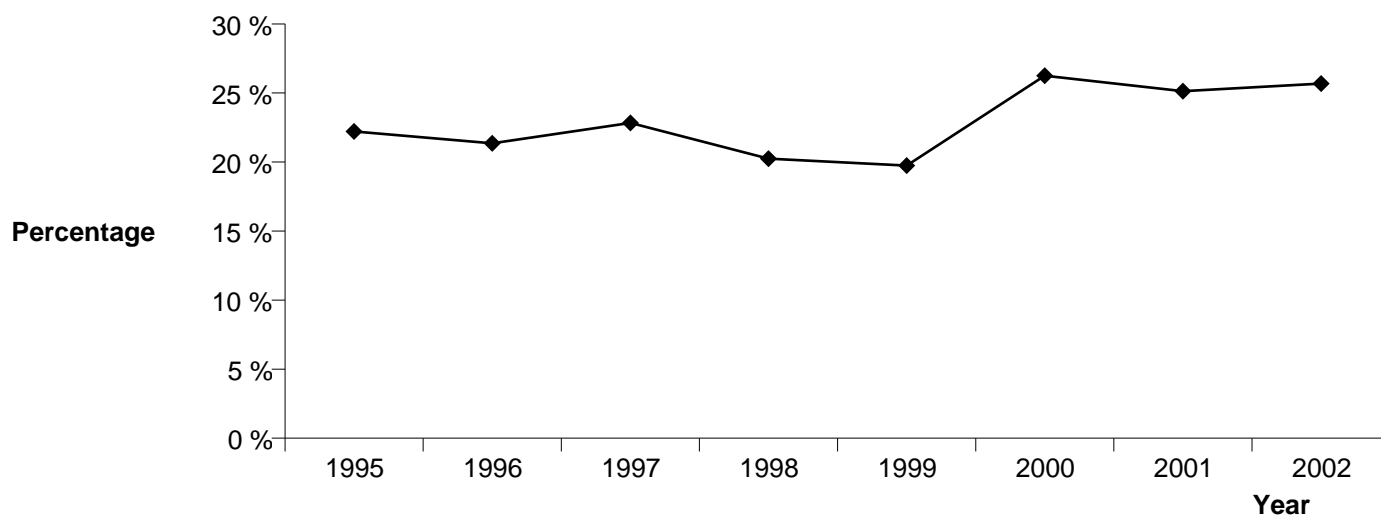

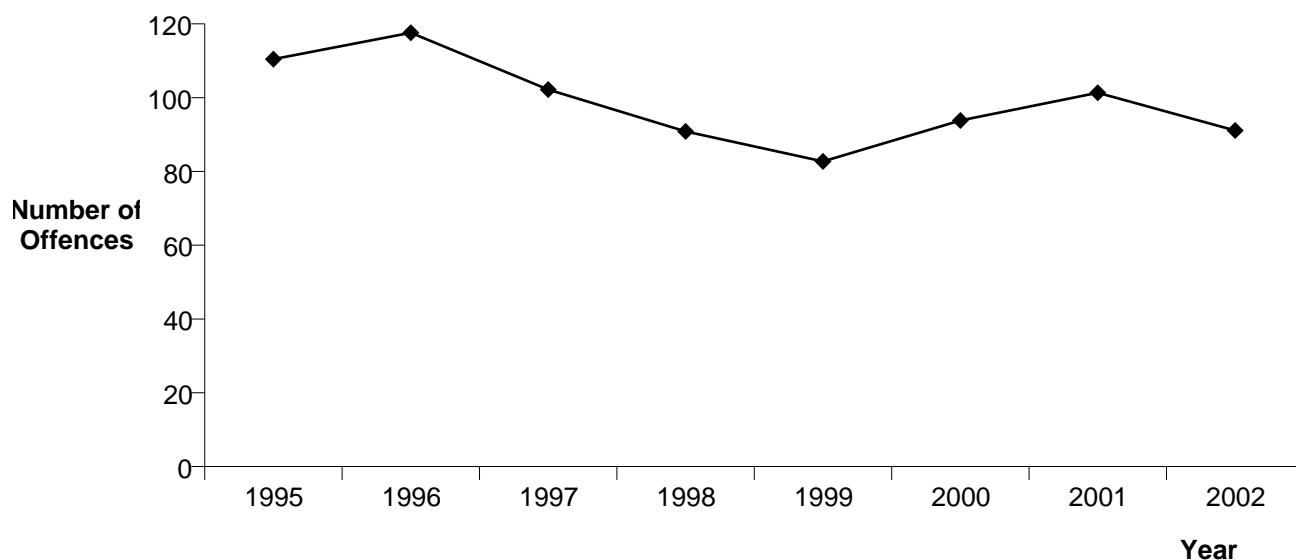

Recorded Property Abuse Offences per 10,000 population



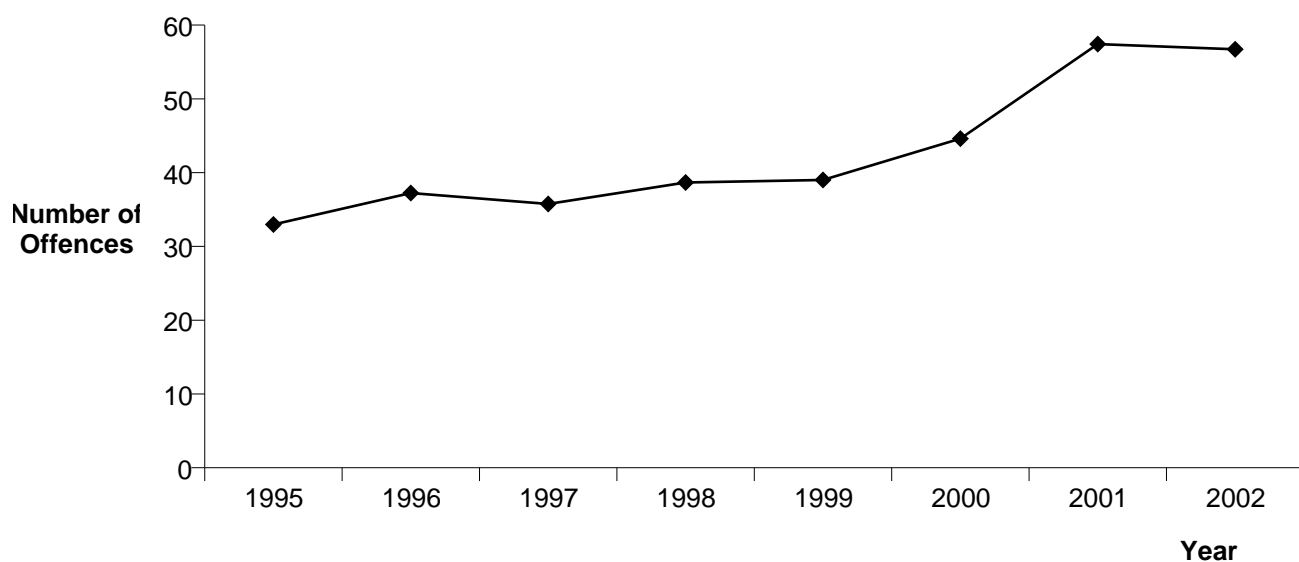

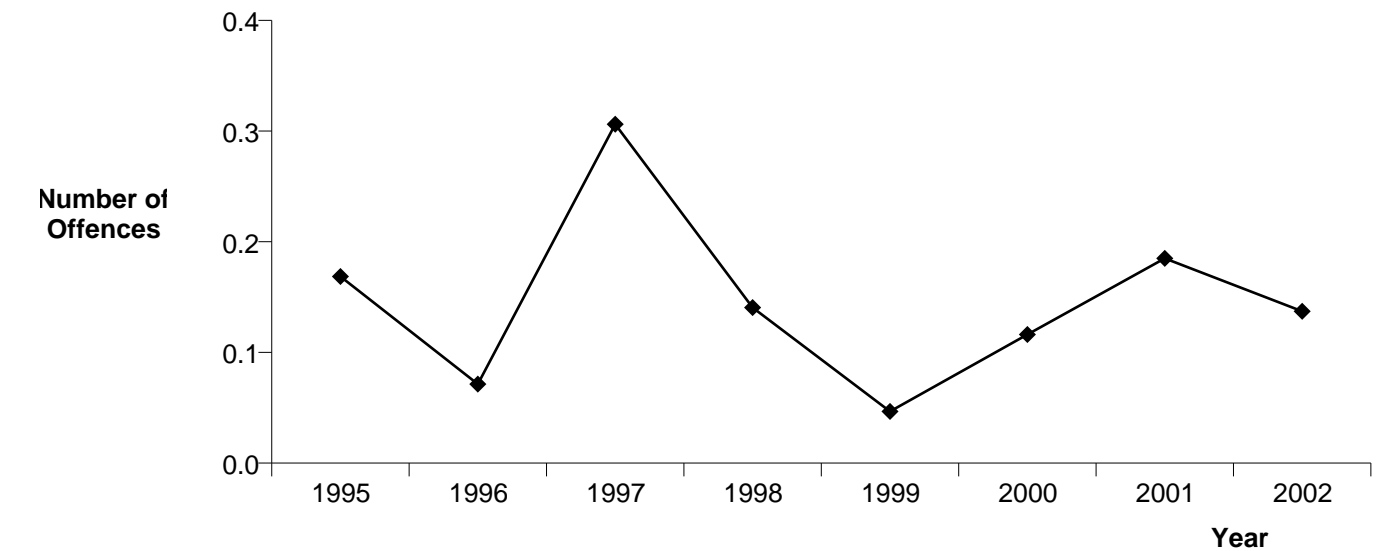

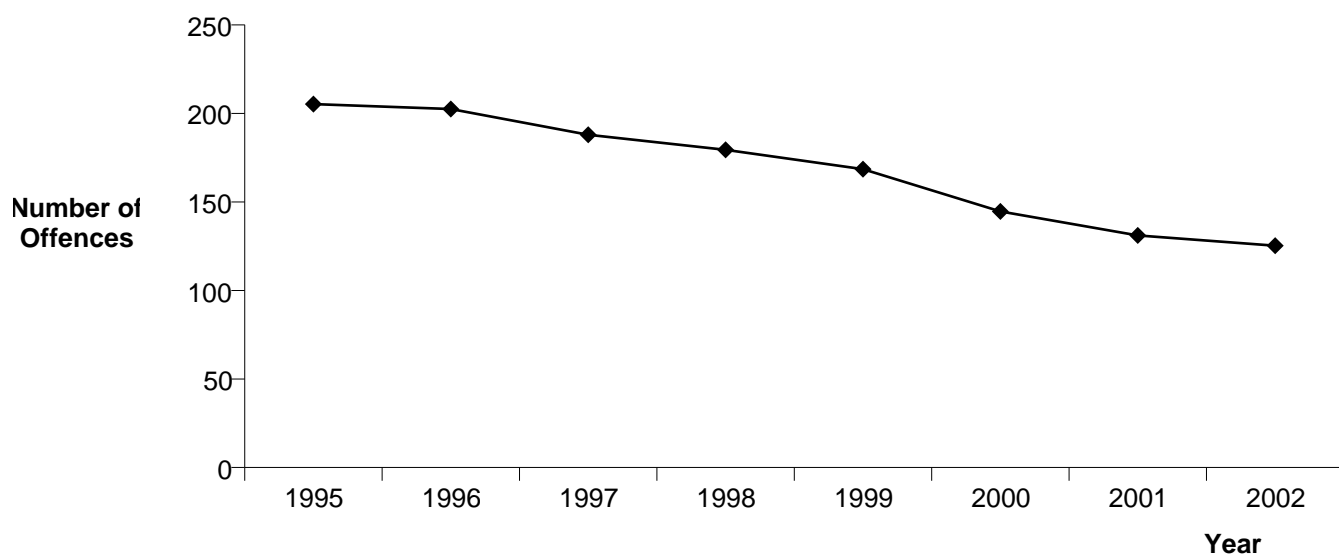

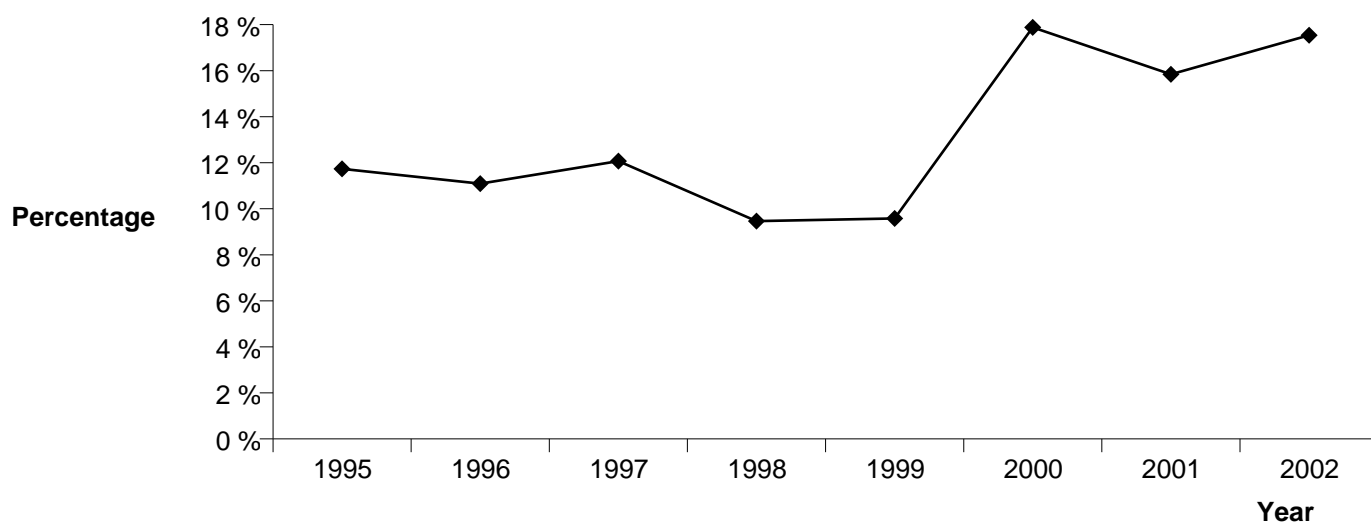

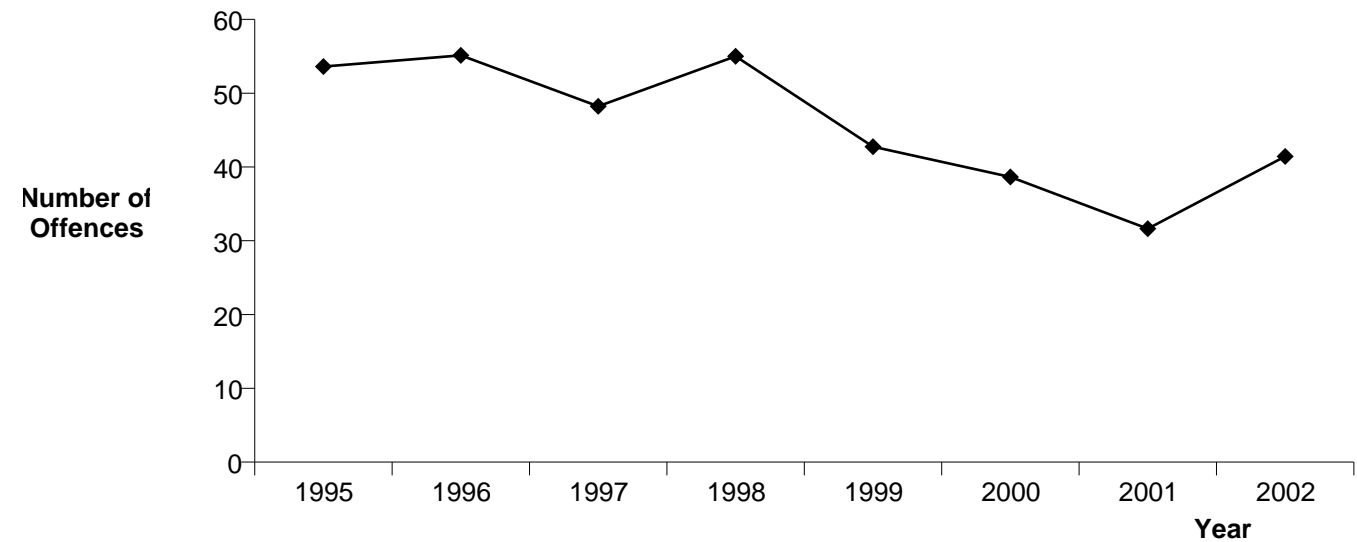

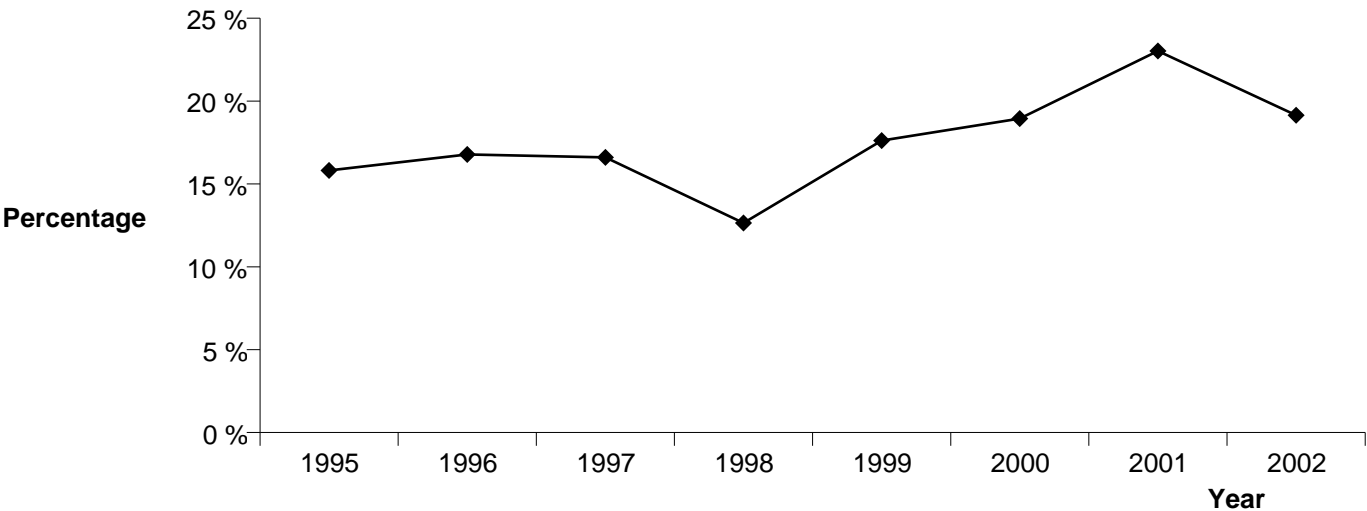

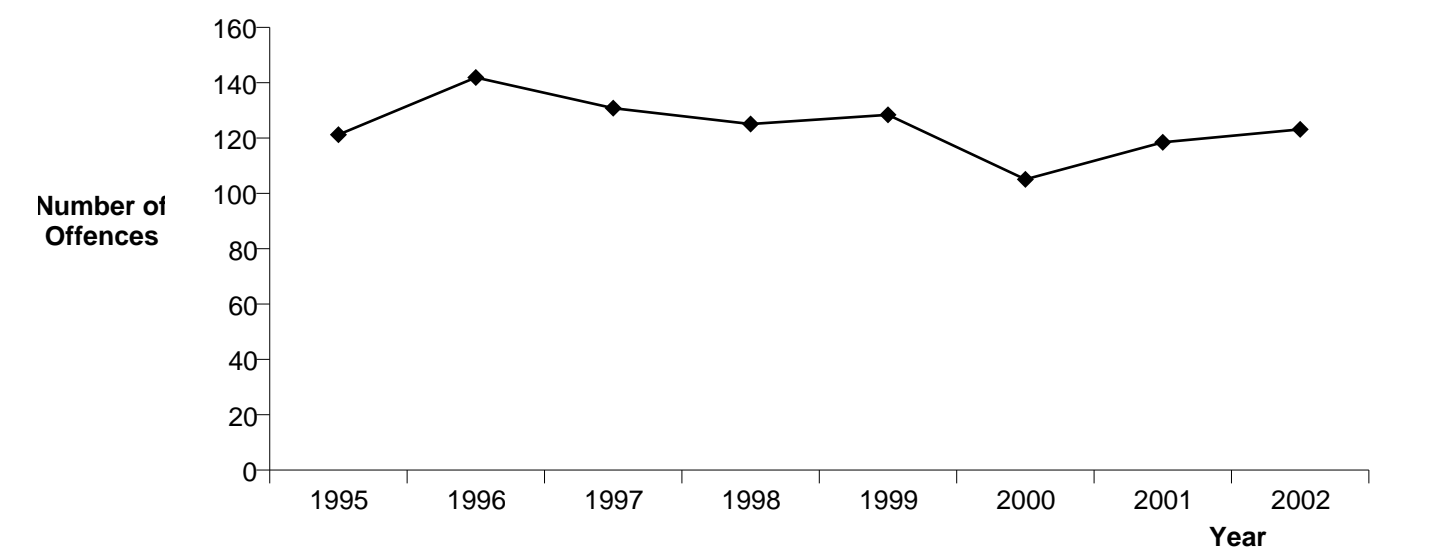

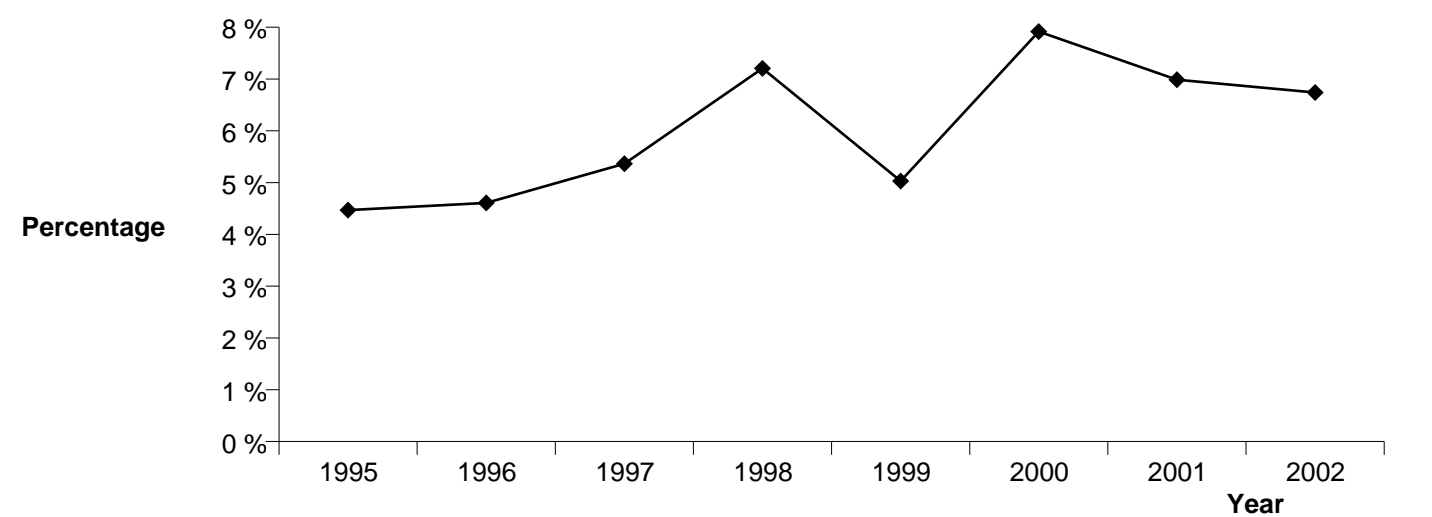

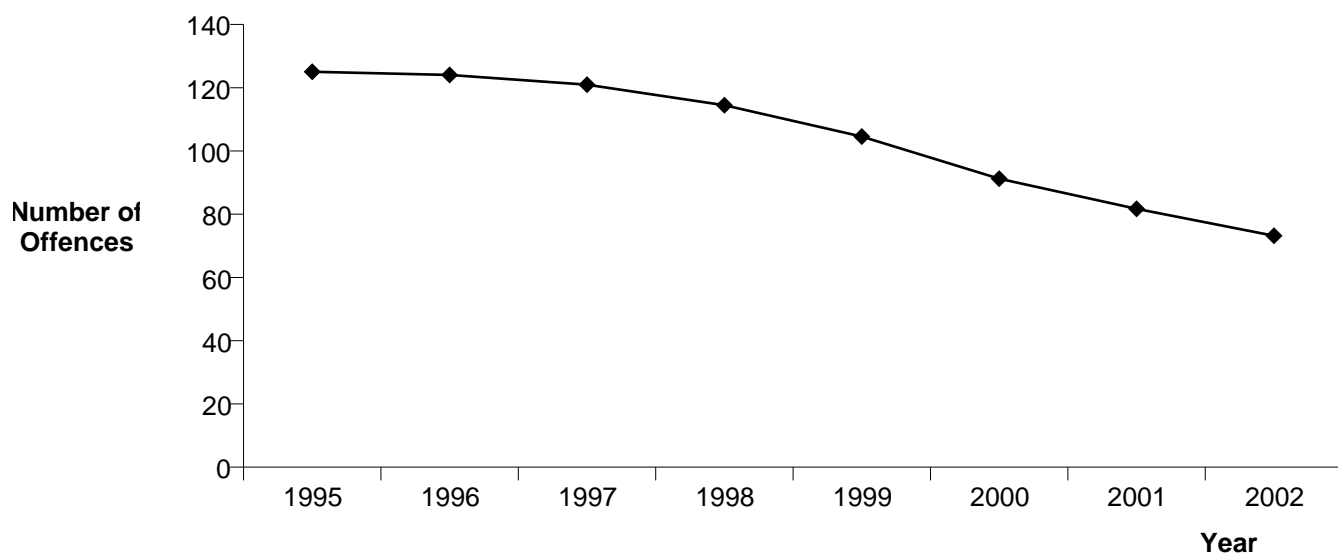

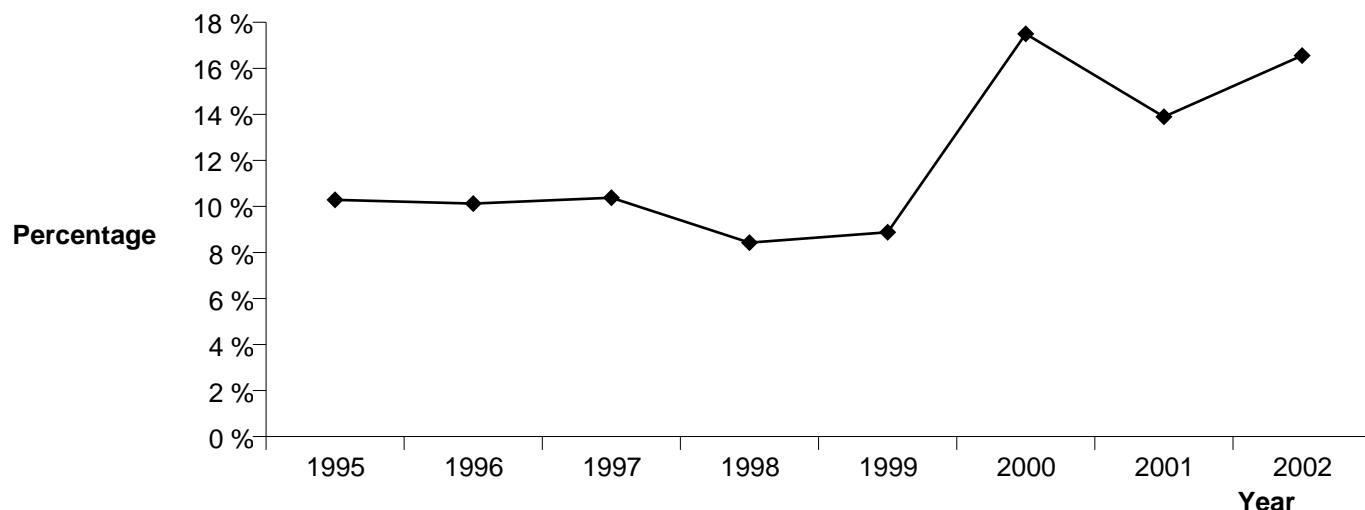
