## **Investment Objectives**

1. Compliance with regulatory requirements.

Police currently detect drug driving after carrying out an impairment test using CIT processes and requesting a blood sample. Under Police are required to implement the Land Transport (Drug Driving) Amendment Act and initiate OFT in line with government directions.

2. Safer roads through improved detection and general deterrence of drug drivers on NZ roads.

Drug driver apprehension is currently limited to detection by officers when a driver is suspected to be impaired by drugs. This is achieved via a CIT test. It is anticipated that a random and compulsory OFT regime like that employed for drink driving, will significantly improve detection of drug drivers and will aid in general deterrence principles.



## **Executive Summary**

The Land Transport (Drug Driving) Amendment Bill progressed through the Committee of the Whole House reading and is scheduled for its Third reading 1 March 2022. If passed the Bill will proceed to Royal Assent.

The OFT Programme will remain in Start-Up phase until Royal Assent has been received.

The Programme continues to develop planning and business artefacts with support and direction from the OFT Implementation Governance Board under the leadership of Assistant Commissioner O'Brien.

### Progress this period

Awaiting the Land Transport (Drug Driving) amendment bill to be passed and for Police to receive Royal Assent.

As at 28 February 2022:

- The new OFT Project Manager Roger Jordan is now in role and handover completed.
- The new Strategic Communications Lead has been appointed and will start 1 March.
- The NIA Reference Group prioritisation request was submitted to NRG.
- Review of the project's engagement strategy began to ensure it maintains relevance and is engaging for personnel in affected work groups.
- The Project's Indicative (Lean) Business Case and costs are being finalised.
- Benefits Realisation and Assurance planning has been finalised.
- A further \$200,000 for OFT Projects' resource costs to 30/06/22 have been allocated.
- The first Interagency Group meeting planned for February was postponed until after Royal Assent has been received. Additional direction has been given from the OFT GB as is being progressed with the drafting on new ToR's for this group.
- Discussion and planning for a new external advisory group to be established. This audience would be formed from those who responded to the Select Committee request for feedback on the Bill and other interested parties in government and private organisations.
- The OFT GB supported commencement of district engagement with RPM's in order to receive feedback on the draft deployment strategy.

## **Next Steps**

As at 28 February 2022::

- Continue development of Project's Indicative (Lean) Business Case, and the work stream Work Packages and Indicative (Lean) Business Cases.
- Confirm the Project's engagement strategy for personnel in affected work groups.
- Await response from NRG on the NIA Reference Group prioritisation request. This will help inform on the forward plan for workflow processes for the OFT BAU teams following delivery.
- The new lead for the Strategic Communications workstream will start 1 March. Work to develop the OFT Intranet site and communication channels will begin.
- Engagement with Waka Kotahi to confirm roles and budget for the advertising and marketing of OFT.
- Finalise Project's Indicative Business Case and artefacts to present to the Board for endorsement.
- Finalise scope and re-forecast for FY21/22 and work with the Programme Office to develop the 22/23 budget.
- The OFT GB will next meet 15 March 2022

#### Status Report Comment:

Mitigation: This risk is not only applicable to OFT but also other road traffic offences. As current ploicy sits, options for supported resolutions are limited to none. Potential options currently used by NZ Police include:

- Te Pae Oranga (Community / Iwi Panels)
- Police Diversion (owned by Police Prosecution Service)
- Traffic Compliance Scheme (Run through the PIB)

In 2019 the courts released the decision of Zhang v R which shifted the mindset of the justice system in relation to the way they approach drug offending. It identified the effects of addictions and the need to help people as opposed to setting harsher punishments for them as a deterrence.


