Investment Objectives

1. Compliance with regulatory requirements.

Police currently detect drug driving after carrying out an impairment test using CIT processes and requesting a blood sample. Under Police are required to implement the Land Transport (Drug Driving) Amendment Act and initiate OFT in line with government directions.

2. Safer roads through improved detection and general deterrence of drug drivers on NZ roads.

Drug driver apprehension is currently limited to detection by officers when a driver is suspected to be impaired by drugs. This is achieved via a CIT test. It is anticipated that a random and compulsory OFT regime like that employed for drink driving, will significantly improve detection of drug drivers and will aid in general deterrence principles.



Executive Summary

Overall the project is progressing to the high-level delivery plan, with the plan being updated once detailed scheduling has been completed.

OFT devices continue to be laboratory tested. Logistics issues have delayed delivery of some devices. The work-stream continues to work with courier services to mitigate.

Work on the Operating Model under which OFT's will be implemented is on-going. Scheduled workshop on 8 August for each work group lead to walk through proposed process changes and review/challenge those proposed changes across the work groups.

Work continues on the Community Consultation for August and September with proposed approach put out for review, collateral being developed and finalised version to be presented for approval.

Minister's update on procurement has been drafted and is out for review.

Progress this period

As at 31 July 2022:

Following the July Board meeting's approval of the recommendation on proposed development for Impaired Driving on the Mobility/Digital platform, a submission for development was submitted and is awaiting prioritisation.

A meeting was held with ESR to clarify roadside process to enable pricing model for blood tests to be created with a follow-up meeting scheduled in August. Business Architecture and proposed Operating Model continue to be developed to support the MVP implementation in March 2023.

Work on the collateral to support the community consultation is underway.

Maureen Carty left the role of Programme Coordinator. All recruitment of new roles (including a replacement for Maureen) based on the Impaired Driving structure has been completed with a Project Manager and Scheduler/Coordinator appointed, both are due to start in the roles on 1 August.

Assess and finalise the new policy updates for impaired driving chapters in the Police Instruction; prepare recommendations for approval from Director Road Policing. Finalise Police's response to medical defences. Commence development of the back office processes.

The change request #947 for FY22/23 drafted with initial currently being socialised. Once approved by ID GB it will be submitted to the Road Policing Sub Portfolio Board for approval.

The Inter-agency Committee met on 21 July 2022, with an action for all agencies on identification of any reporting needs required.

The Impaired Driving/OFT GB will next meet 18 August 2022.

Executive Summary:

The purpose of this workstream is to procure OFT equipment that meet legislative requirements related to the Land Transport Amendment bill. Since the tender closed 27 April 2022, responses and devices have been evaluated with 3 now shortlisted. Due diligence is now being carried out on all 3 to help recommend a preferred device for approval. This includes an independent scientific review on the device's ability to meet the AUS/NZ Standards, followed by a legal review for assurance on whether the devices meet the standards.

Status Report Comment: 04/07/22 - If a suitable OFT device cannot be sourced for delivery in March 2023, a memo to the Minister outlining the reasons why will be presented. The procurement workstream are to seek direction from the Programme if unable to source a suitable device (e.g. whether to retender or negotiate potential customisations with suppliers.)

Description: IF Police are unable to source technology that meets the legislative requirements outlined in the Act, THEN the Minister of Police cannot approve a device and Police cannot carry out an OFT regime.

This risk covers complexity of device, i.e. that it's simple to use, and Health and Safety aspects of taking an oral fluid sample are assessed.

Mitigation: • Clearly and explicitly communicate the legislative requirements in the Request for Proposal (RFP).

- Ensure the Tender evaluation Team only shortlist responses that meet the legislative requirements.
- Directly negotiate with responders that are almost compliant.
- Engage with other agencies and inform stakeholder of outcome of RFP if no device currently available.
- Identify options, i.e. increase use of CIT, in the short term until a fit for purpose device is available
- Incorporate the outcome of not having a device into the communications plan as a back-up

NZ Police has implementing a project on gender and ethnicity which is looking to capture the relevant data in alignment with NZ standards which, once having built the back end standards will look to update frontend data capture.							
	It is proposed that until the organisational standards have been built and standards around capture put in place that this dataset, though included in the dataset collected at the roadside is optional and not used for the purposes of gender or ethnicity based reporting.							

Description: IF gender and ethnicity data is not able to be capture during the testing process THEN this data will not be available for insights analysis WHICH may be perceived as a failing to capture the necessary data and evaluate any disproportionate outcomes

Mitigation: • Alignment of dataset with the broader organisational programme for capture of gender and ethnicity data

- · Incorporate basic capture in the manual forms though this optional and not for the purposes of gender of ethnicity reporting.
- · Using a dataset to identify disproportionate outcomes which is incomplete and inaccurate should be avoided

11/07/22: In addition to the proposed use of the deployment dashboard, community consultation to be held in August and September to receive feedback on the deployment model.

Description: IF the deployment strategy doesn't eliminate the effect of bias when identifying drivers to stop for testing THEN minority groups could be disproportionately stopped WHICH could lead to significant overrepresentation of those Maori and Pacifika groups at all stages of the criminal justice system and impact negatively on Police and Government reputation.
