Executive Summary

Overall the project is progressing to the high-level delivery plan.

The OFT device trial exercise was completed and moderating activities are continuing before the short-listed device/s progress for an 'expert' review, to ensure that the information provided within the responses is accurate and in line with requirements with a focus on appropriateness of level of concentration detection and alignment to standards along with an independent legal review of the device in line with evidentiary standards. This information will be used to inform the recommendation to the Minister of Police when having to review a recommendation. In the interim it is proposed a proactive ministerial update is provided on progress of the procurement specifically calling out any potential risks and the steps being undertaken to mitigate these.

The Tender Evaluation Report is expected to be presented to the OFT GB for endorsement in July.

Following the discussion at the Board in May relating to external engagement, the Programme is looking at the potential for undertaking a Community Consultation process to engage with a broad range of stageholders to gain input into the Deployment approach.



Progress this period

As at 31 May 2022:

Work is in progress to transition the OFT project into the broader Impaired Driving Programme work plan, following endorsement of the new structure and expanded scope from the OFT GB.

The Operational Working Group is progressing policy options and workflow decisions for recommendations to be developed for approval of the Director NRPC. The group are developing workflow maps for new processes and reviewing the legalities for policy changes for Police Instruction updates in alignment with the Act. Members of the PIB, PPS, ESR, ICT, Mobility and Legal teams are involved in the development of new policies, processes and procedures.

The Capability work stream presented the deployment strategy and related CCI to the UPD panel. Endorsement of the strategy will be requested from the Governance Board in June noting that future changes to the strategy may be required due to feedback received through the proposed Community Consultation.

ICT have reviewed and confirmed the ability to host the new charging matrix and process charts (under development) on Checkpoint for officer reference. This will form part of the ongoing discussion on the technology to support the processes.

OFT Intranet landing page was published and panui for staff to alert them to legislation being passed and next steps.

Ongoing and regular liaison between Police, Waka Kotahi, and Ministry of Transport communications representatives on issues and media queries as they arise.

Communications Strategy revised and circulated for first stage of feedback.

Work to develop the Impaired Driving Intranet site and communication channels are underway.

The Procurement work stream completed the OFT device evaluation process for short-listing devices and undertook a device trial exercise at the Plimmerton CVST.; Follow on moderating activities continued in May.

The Insights work stream is being established and will manage data for deployment, collections and distributions and data preparation for the 3-year independent review.

The Interagency Committee viewed the proposed new workflow maps outlining the process options (EBA, OFT or CIT) that the officer has to consider in a roadside stop, through to an outcome of an infringement or charge being issued following blood specimen testing. The Committee discussed data requirements for the 3 year review, including what data is currently collected, and which agency is best aligned for capture of new data requirements.

Governance:

The Oral Fluid Testing Governance Board met on 18 May 2022.

The OFT Board endorsed the new Impaired Driving Programme structure and work is in progress to establish the new work streams.

The S&PGG have been advised of the expanded scope and the new programme structure for Impaired Driving.

The Impaired Driving programme officially moved into the Design/Deliver Phase of the work plan.

Additional funding has been agreed to support the on-boarding of a Change Manager for the Capability work stream and a Project Lead to support the implementation of the Impaired Driving Operational work stream.

Next Steps

As at 31 May 2022:

Progress the reporting requirements to support operational, evaluation and reporting needs.

Policy workshops will be held in June once development of related Police Instruction chapters have been completed.

Planning for an end-to-end walk through of the processes in July.

Work with ICT/Mobility on what digital solution can be developed by March 2023; a solution needs to be understood to confirm requirements for reporting, deployment CCI and strategy finalisation and operational process development.

Recruitment of new roles

Confirm the engagement strategy and progress intranet uploads for staff reference.

Establish the broader engagement approach with a wider external stakeholder group.



Next Steps

The OFT GB will next meet 14 June 2022.

Update the Board on progress made in relation to confirming the broader impaired driving structure.

Review the current risks and issues for the programme.

Present the Deployment strategy and CCI for endorsement.

Review for approval the new ToR's for the Impaired Driving Goverance Board.

Executive Summary:

An Operations Working Group has been established to deliver the operational requirements of the Act. The group will focus on policy, procedures and process changes across Mobility, ICT/NIA/CM, PIB, Police Prosecutions, Legal and ESR business requirements.

Expansion of the scope to include impaired driving requirement has been endorsed by the OFT Board and is being progressed.

Police Instructions are being developed for all components of impairment and will incorporate the new charging decision document to be considered as part of impaired driving, this will include the introduction of both new and combination offending.

ICT are working to confirm a solution(s) to support the deployment model and business integration of the Act in impacted departments.

Overall Status Comments:

This group is responsible for the drafting of policies and procedures and development of policy recommendations for approval of the Director of RP.

Executive Summary:

The Insights work stream is being established. This work stream is responsible for the design and development of the reporting needs. Identifying the needs of operational, tactical and strategic reporting and that the capture of the information is timely, appropriate and necessary.

An initial meeting of the Insights work-stream was held, looking to identify the foundation for the CCI data needs. Through the Inter-agency Committee, Ministry of Transport have identified a "start for ten" dataset of requirements for what they feel will be required for the independent review and shared these with the inter-agency working group. It must be noted that within the dataset are data points which are unlikely to be captured, for example the accuracy of the OFT device in relation to impairment and the detection of false positive and false negative results.



Description: IF Police cannot provide a workable ICT solution to capture necessary testing data THEN data will not be uploaded digitally to the Police systems RESULTING in Polices inability to support the operational processes of enacting the Act and will have impact on the deployment strategy and BAU teams.

The deployment strategy relies on the evidence data as captured in the testing. Police have target testing numbers to achieve in accordance with the Act and these engagements need to be recorded digitially. Manual uploads will impact the Officer and Case Management/FMC teams workloads.

Mitigation: ICT/Mobility teams are working to confirm a temporary MVP solution to enable data capture and reporting until a fully developed impaired driving mobility solution is delivered.
