Minister's Foreword



The spreading influence of organised crime is one of the biggest law and order issues facing New Zealand.

With huge profits to be made from the sale of methamphetamine and other illegal activities, gangs have evolved into sophisticated criminal networks.

The downstream effects of organised crime – drug-related property crime, corruption and violence – reach deep into our communities. If New Zealanders are to feel safe on their streets and in their homes, these criminals must be stopped.

Putting organised crime out of business is a priority for this Government.

We have given Police the resources and the legislative tools they need to detect and dismantle organised crime networks. We have passed legislation to combat money laundering, punish participation in organised crime and seize illegally obtained assets.

The Criminal Proceeds (Recovery) Act and the new Assets Recovery Unit will spearhead our efforts to deprive organised criminals of the assets.

I welcome the ongoing commitment by Police to counter organised crime and make New Zealand a better, safer place to live.

Organised crime affects all levels of society, every region of the country and every sector of the economy. Therefore, combating organised crime is all of our responsibility. Organised Crime in New Zealand

Today's organised crime networks are agile, innovative, operate across international borders, embrace new technology and continuously exploit new opportunities.

Organised crime in New Zealand is perpetrated both by traditional groups with established hierarchies and fluid criminal networks without rigid structures. Some organised criminal groups operate like sophisticated multi-national businesses. Individuals may also use membership of a criminal gang to facilitate their offending.

Organised crime networks and gangs in New Zealand are involved in:

- · illicit drug trafficking, manufacture and distribution
- burglary and vehicle crime
- violence and intimidation
- electronic crime
- identity crime
- financial crime
- environmental crime

How We Combat Organised Crime

New Zealand Police target, disrupt and dismantle organised crime. Our approach is built upon first-class intelligence, targeting key criminal groups and maximising use of legislative powers. We achieve this through:

- a National Organised Crime Control Strategy with concrete actions and clear measures
- a National Intelligence Centre that provides current and comprehensive organised crime intelligence
- hosting of the Organised and Financial Crime Agency NZ
- dedicated District based operational Organised Crime Units
- focused investigations cemented by first-class intelligence
- attacking the profits of crime though targeting of criminal assets
- using technology and covert capability to infiltrate and gather evidence of organised crime

Core Values

Combating organised crime is a whole of Police priority - everyone has a role to play

Intelligence Led

New Zealand Police has built a first-class intelligence model to combat and reduce organised crime. The model gathers, analyses and distributes detailed and current criminal intelligence to proactively target and prosecute organised criminals.

Organised Crime entities and individuals will be analysed to ensure those creating harm in the community will be prioritised for targeted responses.

Tasking and Coordination Groups across Areas and Districts will strengthen the police fight against organised crime by coordinating police activities.

Community Focused

New Zealand Police deploy a community focused approach to tackling organised crime.

This involves all of Police. partner agencies. non government organisations and individual citizens. Agencies, organisations and individuals have a key understanding of what is happening in their community. They are critical eyes and ears in the prevention and disruption of organised crime and enhance our intelligence led approach.

By actively listening to local people we develop and implement robust, relevant and effective responses. This ensures public confidence and builds resilience to organised crime.

Community Policing - Intelligence Led - Priority Tasked

Effective action to disrupt and dismantle organised criminality requires logical and informed deployment decisions. We achieve this through our community focused, intelligence led approach.

Strategic Aim: To disrupt and dismantle organised criminality impacting on New Zealand

The **Police Organised Crime Control Strategy (RESTRICTED)** is a practical, action focussed document to direct police efforts against organised crime. It contains concrete activities with clear, achievable measures guided by the PIERS framework of:

Prevention Intelligence Enforcement Reassurance Support

The Police Organised Crime Control Strategy was launched in March 2010 and will be updated annually

Oversight

The Deputy Commissioner: Operations has responsibility for delivering the Police Organised Crime Control Strategy.

The Police Executive Committee, National Managers, and Service Centre Managers are responsible for aligning their business practices to the Organised Crime Control Strategy.
