- Poorly maintained and incorrectly painted school patrol crossings (kea crossing and pedestrian crossing) in the Whangarei area.
- In the second second

Opportunity

 For Police, council and school communities to work together to prevent road trauma around school crossing points.

Result of the partnership

- All of the crossings have been fixed.
- Any further problems that have been identified have been quickly rectified or included into the council's long term plan.



Totora Grove School Kea crossing







- Incorrectly painted Kea road markings.
- Children confuse Kea Crossing with Zebra Crossing
- Visibility from South on Paramount Parade
- Legislative Consideration: "8.4(5) A road controlling authority must indicate the presence and position of a school crossing point by marking or installing in accordance with the relevant requirements of schedule 2.

- Incorrect painted road markings removed.
- Protective centre island put in place to assist students crossing the road.
- All children from the school taken through the new Kea crossing system.

Horahora School Kea crossing





- Patrollers' view obstructed, particularly from a child's perspective
- Legislation "The W16-4.1 children flag on each approach should be mounted so it ... does not obscure the school patrol's view of approaching traffic."

- Changed the removable fluorescent orange (red `children' flag) post to an appropriate height to prevent obstructing patrollers view.
- Extended the no stopping lines to assist the school patrollers.

Totara Grove School Pedestrian crossing



Before Modification



- The new pedestrian crossing was placed too close to busy roundabout.
- School Traffic Safety Team members at risk of being hit by vehicles or school patrol sign as vehicles enter intersection from side road.

- The pedestrian crossing was moved back to its original site further up the road (see photo).
- Teachers were stationed to oversee the crossing before and after school to assist children crossing.

Kamo Intermediate Pedestrian crossing



Missing Centre lines

lssues

- Different sized signs.
- Missing painted lines.
- Very busy road.
- Large number of students.
- Only one safety island





- Replace stop signs with appropriate evenly sized signs.
- Repaint the pedestrian crossing.
- Fit another protective traffic island to assist patrollers.
- Fit a centre traffic island to assist crossings.

One Tree Point school Pedestrian crossing





- No Belisha beacon disc or 300mm Illuminated amber globe.
- No black and white pole.
- Old Kea crossing posts.
- Busy road.

- Removed old Kea crossing flag posts.
- Installed black and white poles with Belisha beacon disc or 300mm Illuminated amber globe (which may flash).
- Installed temporary 40km speed zone lights.

Results of working together

- All of the crossings have been modified and made legal.
- Modifications included as applicable:
- The Kea crossing flags have been raised and posts lifted.
- A limited speed system has been installed.
- Two centre island systems have been put in place.
- Poles have been updated and repaired.
